- **2008-2009** vendor fee is **\$450 PLUS 10%** of your gross sales. These fees apply to **ALL** Cheer Fest events, excluding the Cheer Fest Ultimate Nationals.
- **A deposit of \$225 is due 30 days prior to each event and the balance of \$225 and 10% is due at the conclusion of each event.**
- **ALL payments are non-refundable.**
- The vendor fee for Cheer Fest Ultimate Nationals will be announced by February 1, 2009.
- Cheer Fest accepts cash, credit card or certified funds only for deposit. **Please do not send cash in the mail.**
- Cheer Fest operates on the **HONOR SYSTEM** based on your sales at the event. We will not audit your sales or require any written reports. Our company philosophy is that we trust our business partners until given reason not to. Cheer Fest Staff will make observations of the activity at your booth at each event. You will be required to pay your 10% gross sales and \$225 balance in cash or credit card at the conclusion of each event.
- Your gross sales should be calculated based only on your sales at the event. There should be **NO** expenses, including travel deducted from your total sales, except the \$450 vendor fee.
- Cheer Fest **DOES NOT** guarantee exclusivity for any event. We will make every effort to be considerate of each vendor and their merchandise being sold.
